1884. Report from the Police representative:

Report received from Inspector Muirhead

Inspector Muirhead explained that the Nelson meeting clashed with another Community Council so he would normally only be able to attend every other meeting but would endeavour to ensure a Police representative would attend whenever possible.

13 Crimes reported in February which did not raise any specific issues of concern.

Issues raided by Members:

Cllr Gray - Smell of weed out side Llanciach, possibly by adults collecting children from School. Inspector Muirhead agreed he would pass this on to the area Policing Team.

Parking on zig-zag line which had caused a near miss

Cllr Mahoney - Concern raised regarding ASB by teenagers, 101 had been contacted but no response - Inspector Muirhead to investigate

Cllr Blackman - raised the issue of 20mph zones which Inspector Muirhead explained was a local authority issue. It was agreed it would be placed on the Agenda for the next meeting.
